In order to reduce compliance burden and deregulation for ease of Doing Business and also to ensure timely disposal of consent applications for **Revalidation of Consent to Establish certificate** the Arunachal Pradesh State Pollution Control Board (APSPCB), hereby issues the following order for effective implementation in the state.

**Third party Inspection / Certification for revalidation of consent to Establish Certificate:**

The Third-party Inspection / certification is hereby introduced for all categories of Industries having capital investment **up to Rs 50 lakhs** for issue of revalidation of consent to Establish the procedures / guideline for empaneling the list of agencies / environmental auditors for Third Party Inspection / Certification is enclosed as **Annexure A**.

**NB:** - In the case of closure order / court case pending before National Green tribunal / any Judicial Authority / Appellate Authority, the provisions of Re validation of consent to Establish Certificate will not be applicable till disposal of the court case / satisfactory compliance.

## **Annexure I**

### **The Procedures/guidelines for empaneling the list of agencies / institutions/ environmental auditors for Third Party Inspection / Certification**

**The Third-party Inspection/certification is hereby introduced for all categories of Industries having capital investment up to Rs 50 lakhs for issue of renewal of consent to operate. The procedures/guidelines for empaneling the list of agencies / environmental auditors for Third Party Inspection / Certification are as follows: -**

- i. The Arunachal Pradesh State Pollution Control Board (APSPCB) will empanel the list of agencies / institution / environmental auditors for Third Party Inspection / certification.
- ii. The empaneled agencies / Institution / Environmental auditors will be entrusted to inspect the project / industries to check the compliances of terms and conditions of consent to Operate Certificate, Environment clearance (If applicable) & air monitoring / stack monitoring, other environmental parameters as notified from time to time.
- iii. The Choice of agencies / institution / environmental auditors for a specific industry shall be made by the applicant from the panel of agencies / institution / environmental auditors.
- iv. The board may at its discretion notify individual units / industry (on the basis of public complaint / court case etc.). In these cases, normal inspection will be made by the Board.
- v. The Project Proponent / Industry shall have to bear the expenses incurred towards inspection and monitoring by the empaneled agencies / institution/ environmental auditors for the Third-Party Inspection / certification.
- vi. The applicant would be required to upload the Third-Party Certificate along with the requested fee on the Arunachal Pradesh State Pollution Control Board (APSPCB) portal and on the basis of the Third-Party Certificate; the Consent to Operate (CTO) shall be auto renewal.
- vii. The charges for Third Party Certificate to be paid to the agencies shall be fixed separately, and shall be borne by the applicant/ industrial units/Project activities.
- viii. The Board would carry out random inspection of such unit to verify the compliances, and authority of the Third-party certification.
- ix. If the Board is of the opinion that it is expedient in the public interest that certain industry needs to be closely monitored / examined by department before Renewal of Consent to Operate (CTO), the board may be order, published names of such units and upon such order, the said units shall be

excluded from the ambit of Third-Party Certification.

**Procedure for submission of online application for obtaining renewal of Consent to Operate Certificate.**

1. Application:
  - a. The Proponent shall submit Application online through either in eodb.arunachal.gov.in portal or OCMMS portal
  - b. The applications must be filled as per instructions and submitted with the required documents.
  - c. When the application is filled up and submitted, a message/ e-mail will be sent to project proponent as well as scrutiny officer.

**Processing of the Application**

- a. The application would be scrutinized by the scrutiny officer and if any query raised by Scrutiny officer, then the applicant would be required to address the query.
- b. Subsequently, if the application is found to be in order and all the attached documents is meeting requirements, the application would move to the Approval Authority.

**Required Documents:**

- a. Consent to Operate (CTO) Certificate
- b. Third Party Certificate from empanelled agencies/institutions identified by Arunachal Pradesh State Pollution Control Board (APSPCB) in case of renewal of Consent to Operate Certificate.
- c. Consent fees (Net Banking, Debit card, NEFT/RTGS).
