Directions under Section 18(1) (b) of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (1) Air (Prevention & Control of Pollution) Act, 1981 and in pursuance to the Notification issued by the Ministry of Environment, Forest and Climate Change (MoEFCC), Government of India vide Notification No G.S.R.761(E) Dtd 17th October 2025 and in continuation of earlier Circular issued vide Memo No 93/2017/RCI/4456 Dtd 05.05.2025, the State Government in consultation with the Arunachal Pradesh State Pollution Control Board is pleased to make further amendment to the list of Industrial Plants or Sector under Sl .V of the of earlier Circular Dated 05.05.2025 as notified as follows:

Sl V. List of White Category of industries/Sectors

After entry 54, the following entries shall be added therein:

55.	Distilled water using only electricity (<1KLD capacity) *
56.	Agro-produce processing units having capacity more than 0.5TPD but less than 1 TPD, using only cleaner fuels –electricity or gaseous fuel (without effluent generation)
57.	Assembling units and mechanical workshops (without heat or surface treatment or spray painting)
58.	Bakery, confectionery, and sweets production units having capacity more than 0.5 TPD but less than 1 TPD, using only cleaner fuels –electricity or gaseous fuel and with having permission to discharge in municipal sewerage system connected to Terminal STP*
59.	Cleaning and other brushes manufacturing through dry mechanical process (without moulding and without effluent/emission generation)
60.	Cattle/fish/poultry feed pellet making(only palletisation unit without boiler and effluent generation)
61.	Cement products (without using Asbestos) like pipe, pillar, jafri, well ring, blocks/tiles etc. (< 1 KLD capacity)*
62.	DPC (paper coating) of copper and aluminum wire (only dry process)
63.	Food and food processing unit (having capacity more than0.5TPD but less than1 TPD) using only cleaner fuels -electricity/gaseous fuel, with having permission to Discharge in municipal sewerage system connected to terminal STP*
64.	Fuel dispensing unit only without automobile servicing repairing and painting
65.	Gold Assaying & Hallmarking Centres.
66.	Industrial items from engineering plastics by fabrication process only (without moulding).
67.	Manufacturing of all types of threads, cordage, twines etc.(without ginning)
68.	Manufacturing of cotton vicks, tapes, bandages, adsorbent cotton etc.(y process without boiler and effluent generation).
69.	Manufacturing of Domestic Hardware and Utensils (Without heat/surface treatment/effluent generation)

70.	Manufacturing of products by only cutting/ stitching/ gumming (without effluent/ emissions generation)
71.	Manufacturing of products through physical mixing only like-Floor Polish, Nail Polish, Hair Oil, Shampoo, Tooth Powder, Tooth Paste, Perfume, Hand Sanitizer, (Micro and small scale operations).
72.	Manufacturing of sanitary napkins/diapers fixing and sealing (Small and Micro scale units without effluent/emission generation).
73.	Manufacturing of Stationery Items (by assembling, and cutting or punching or stapling or binding etc.)
74.	Metal fabrication works and hand tool manufacturing through machines (without heat or surface treatment or spray painting).
75.	Oil mill ghani and extraction no hydrogenation refining with capacity not exceeding 500 kg/day*
76.	Packing of food items (without processing).
77.	Paints and varnishes mixing and blending (without ball mill and only dry process)
78.	Plastic wire, net, nivar and other products (dry process through looping, twisting, cutting etc.)
79.	Puffed rice or murhi or chura with capacity not exceeding 1TPD per day*
80.	Rice mills holler machine with capacity not exceeding 1TPD per day*
81.	Small scale restaurant or hotel without room/cloud kitchens or Resorts (without stay/room facility)*
82.	Sports Goods Manufacturing Units (without seasoning of woods)
83.	Decoration of ceramic cups & plates by electric furnace 62.63. 64.
84.	Detergent powder manufacturing (handmade-without steam boiling or boiler)*
85.	Digital Printing on flex or vinyl, PVC etc. (less than 5 machines)*
86.	Herbal powder products making without extraction (dry process-without emissions or effluent generation)
